

UNION SETTLEMENT FEDERAL CREDIT UNION ATM Card

Do your banking anytime-day, night, or weekends, 24-hour, 7 days per week. Just fill out this form and return it to us. Your ATM Card will arrive directly at your home within two weeks.

The Personal Identification Number (PIN) is computer generated/selected and will arrive 2 or 3 days after the card. Member selected PIN option is available.

You can use your card at any SURCHARGE-FREE ATM within the CO-OP Network. Your ATM card can also be used for purchases at any location that accepts the NYCE or PLUS Card.

CASH LIMITS

Cash limits are \$300.00 per day. The day starts at 3:30 p.m. and ends at 3:30 p.m. the next day. The weekend, Friday afternoon through Monday afternoon, is considered one day.

BALANCE

It is your responsibility to keep track of the balance in your account. The balances in the ATM are updated twice a day, Monday through Friday. Transactions after 3:30pm on Fridays are not updated until Monday.

You may check your balance by calling the AUDIO System at 212-828-0340, 24 hour per day, 7 days per week.

OVERDRAFT

If you exceed the balance in your account, you will be charged an overdraft fee per transaction. ATM privileges will be revoked if account is overdrawn (3) three times.

UNION SETTLEMENT FEDERAL CREDIT UNION ATM Card

Use your Credit Union ATM Card for:

- withdrawals up to \$300
- balance inquires
- transfers between accounts (checking - savings)
- purchases (for checking account holders only)

Keep your Personal Identification Number (PIN) confidential

- your PIN is for your use only
- do not write your PIN on your ATM card
- never give your PIN over the phone
- record your PIN and keep it in a safe place

Treat your card like cash, checks, credit cards

- keep it secure when not being used
