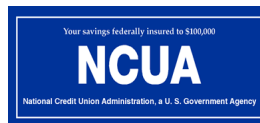

# SHARE DRAFT ACCOUNT AGREEMENT WITH OVERDRAFT TRANSFER AND DEBIT CARD CLAUSE

I hereby authorize **UNION SETTLEMENT F.C.U** to establish this Share Draft for me. The Credit Union is authorized to pay share drafts signed by me and charge all such payments against the shares in this account.

It is further agreed that:

- The Credit Union is under no obligation to pay a share draft or honor any other payment request that exceeds the fully paid and collected share balance in this Account.
- I understand that debit card transactions will be withdrawn from my/our share draft (checking) account
- If I choose to have overdraft protection. A maximum of six transfers a month will be allowed. Afterward I will be responsible that funds be deposit in checking. Under regulation D after you reach a total of 6 transfers any additional transfer will be rejected. Item will be returned and a fee will be impose for every return posted to your account.
- I agree to deposit funds sufficient to cover the check card transactions within forty-eight (48) hours of notice of such overdraft. In the event I do not abide by the terms of this agreement, the Credit Union may bring an action to collect any outstanding charges, in which case I will be responsible for all reasonable attorneys' fees and court costs with interest being charged at the same rate as the credit card charges.
- Except for negligence, the Credit is not liable for any action it takes regarding the payment or non-payment of a share draft or other payment.
- When paid, share drafts become the property of the Credit Union and will not be returned either with the periodic statement of this Account or otherwise. Copies of such share drafts will be provided, if requested, and the Credit Union may charge a fee for providing such copies.
- This Account is also subject to such other terms and conditions as the Credit Union may establish from time to time. Such other terms and conditions include, without limitation, services charges for stop payments orders, draft and other item returned for insufficient funds, and any other services as designated by the Credit Union.
- Any shares in the share account may not be issued as collateral security for a loan. Any funds desired as security must be transferred to a regular share account.
- Any objection regarding an item shown on a statement shall be waived unless brought to the credit union in writing within 60 days following the statement date.
- All non-cash deposits received in the account are subject to the funds availability procedures of the credit union
- Share draft account may be closed at the discretion of the credit union without prior notice if the credit union suspects fraud or abuse of the account.
- Debit card (s) are the property of Union Settlement Federal Credit Union and they may be revoked at any time for abuse or fraudulent activity or any time the credit union deems necessary to avoid loss.
